**5446 Police Report – None received.**

Cllr Pearson informed the meeting of a spate of burglaries around Lomond Gardens, Cherry Tree. Police have been involved & there was concern about the public footpath that runs towards the playing fields and the canal being used as a getaway route for the thieves. Cllr Pearson is to look into the possibility of a footpath closure through BwDBC.

Cllr Simm reported excessive mud on the road on Preston Old Road from Fieldens roundabout to Tintagel Close – dangerous when wet/icy.

Also, problems near all the new development sites with lack of road sweeping.

**RESOLVED:** To ask the Parish Clerk to write to BwDBC regarding the conditions on the planning applications.

Representation from a member of the public – Mr Starkie, 684 Livesey Branch Road, Blackburn – he came to ask for the Parish Council to help him with the problems he is having with his neighbours. Mr Starkie was advised that the matter was a civil one that the parish Council could not get involved in and suggested he spoke with a solicitor. As Mr Starkie seemed to need support moving forward with the issues Cllr Croasdale offered to meet him outside of the Parish Council meeting and help him format a plan of action, however, Mr Starkie refused the offer.

Cllr C Hardman mentioned the problems with the lack of parking enforcement on Buncer Lane outside Witton Park School even though signs and lining in place.

Cllr Marrow commented that unfortunately some of the schools do not have the correct parking restrictions in place or the correct markings, therefore, unable to enforce parking tickets etc.

Cllr Pearson mentioned if it would be possibly for the parish Council to undertake the implementation of the correct Traffic Orders and lining.

#### **5450 Defibrillator**

As the purchase of the defibrillator had been agreed at a previous Parish Council meeting it was agreed that the Parish Clerk be requested to send monies to the company agreed to supply the defibrillator and to also enquire about training dates so that all relevant persons can be invited. Also, the Parish Council would contact the Telegraph for a photo shoot to let residents know in the local news that it was available.

**RESOLVED:** Parish Clerk to arrange purchase of defibrillator & request training day dates.
